Our consultants are available for on-site consulting visits at our standard hourly rate of \$220-\$280 per hour. Travel time is billable at half of the standard rate, and other out-of-pocket expenses such as mileage, parking, etc., are also chargeable. Payment for the initial visit is due during the first visit and net 10-day terms are allowed for subsequent visits.

We also provide telephone technical support. The charge is \$55-\$70 per 15-minute increment. We require a MasterCard, Visa, or American Express credit card to be on file to receive phone support. Live Remote Assistance is available for an annual fee of \$300 or a single-call fee of \$50 with our Premium Support Plan. It covers the expenses for Live Remote Access only; actual session time is billed separately.

If you are interested in training, North Star Ventures provides individualized training for Sage 50, Intuit and Act! products.

Demonstrations of QuickBooks, Sage 50, Peachtree, and other software products are available in our office by appointment. We will assess your requirements and advise you on the suitability of the product for your business. Demonstrations generally last between 1 to 1½ hours, and the rate is \$220-\$280 per hour. Payment by check or credit card is expected on the day of the demonstration.
